1st Cracovian Forum of Viticulture, Enology and Vinotherapy
VITI-ENO-PHARM 2020

§1. General Provisions

5. The Conference shall be held **from April 24th to April 25th, 2020** in International Cultural Centre, Rynek Główny 25, Kraków (Day 1) and Jagiellonian University Vineyard „Nad Dworskim Potokiem”, Łazy 2, Rzeszawa (Day 2).
6. The main aim of the Conference is to summarize all the achievements of the oenological environment to date, show directions for further dynamic development of the wine industry in our part of Europe and emphasize the importance of Vinotherapy.
7. The conference language is English, French and Polish.

§2. Registration

1. Registration for the Conference is possible by completion of the **Registration Form** available here: <https://forms.gle/3qfko5x7aQyxhdq19> .
2. Registration will be open till **25th March 2020**.
3. By registering, the Participant agrees to the collection, preservation and processing of personal data contained in the registration form, by the Organizer for the purposes of arranging a conference. The administrator of personal data is the Organizer.
4. A registered Participant may cancel the application by writing to the Organizer an e-mail, unless the conference fee has already been paid.

§3. Forms of the Participation

1. The Participant registering in the conference system declares the way of participation (passive or active participation).
2. Active participation is available in two forms: Oral presentation in SCIENTIFIC MODULE: Enology & Vinotherapy (24th April 2020) OR Presentation of Vineyards, Winemakers and Wines in WINE MODULE combined with Tasting Workshops (25th April 2020).

a) Oral presentation in SCIENTIFIC MODULE: Enology & Vinotherapy (24th April 2020):

- the abstract is required – see the section below (**§4. Abstracts**).
- the presentation time is 12-15 min. in total (10-13 min. of presentation + 2-3 min. for a short discussion). The Participants are kindly requested to plan their presentation in order to match to the predicted time.
- participants are kindly asked to hand over their presentation file (.ppt, .pptx or .pdf file) to the staff, possibly the 3 days before the conference. Presenters will have an opportunity to update their files during the coffee break before sessions.
- The presentation should be sent to the Organizer in advance to the e-mail address: vitenopharm.presentations@gmail.com **by the April 21, 2020**.

b) Presentation of Vineyards, Winemakers and Wines in WINE MODULE combined with Tasting Workshops (25th April 2020):

- the abstract is not required.
- the presentation time is 15-20 min. + 5 min. for a short discussion (optionally).
- If needed: participants are kindly asked to hand over their presentation file (.ppt, .pptx or .pdf file) to the staff possibly the 3 days before the conference. Presenters will have an opportunity to update their files during the coffee break before sessions.
- If needed: The presentation should be sent to the Organizer in advance to e-mail address: vitienopharm.presentations@gmail.com **by the April 21, 2020.**

3. Each participant, both active and passive, will receive a **certificate** confirming participation in the Conference.

§4. Abstracts

1. The template of the abstract is available on the Conference website. Participants are kindly ask to prepare the abstract in accordance with the guidelines.
2. The abstracts should be sent to the e-mail address: vitienopharm2020@gmail.com by the **March 25, 2020.**
3. If the number of submitted abstracts will be large, the Organizer reserves the right to select abstracts and make additional poster session for participants not qualified for an oral session
4. Abstracts sent during registration process will be collected and published in a form of the Book of Abstracts.
5. All published abstracts will be containing following information: the authors names, the authors affiliation and e-mail address as well as the acknowledgements.

§5. Conference Fee

1. The person willing to participate in the Conference is obliged to make a payment for participation in the Conference.
2. The Conference Fee is **450 PLN** (the same for Active Participants and Passive Attendees).
3. The fee should be paid by the **March 30, 2020.** The already paid conference fee will not be returned. Lack of payment will result in removal from the List of Participants.

5. As a part of a one Conference Fee, there is a possibility to submit **two abstracts.**

6. **The Conference Fee includes:** conference materials, coffee breaks, lunches, gala dinners, tasting workshops, bus transfer from Krakow to the Jagiellonian University Vineyard "Nad Dworskim Potokiem" in Łazy and back, translator (English, French).
